Since 1973, the annual North of the River Christmas Parade, originally known as the North Bakersfield Recreation and Park District's Children's Christmas Parade, has spread holiday cheer to North of the River residents and Bakersfield. As our hometown parade celebrates its golden jubilee, North of the River Recreation & Park District (NOR) invites community members to submit memories of their times attending, walking in, and enjoying the parade in the form of written stories, photos, audio clips, and/or a video. These submissions will be utilized as part of a larger storytelling effort to celebrate the history of the Oildale and North Bakersfield community and the role NOR has played.

TERMS AND CONDITIONS FOR SUBMISSSIONS

By providing a submission, you are agreeing that:

- You are solely responsible for the content that you submit and the consequences of submitting content.
- You are at least 18 years of age.
- While you retain ownership of your submission, you grant NOR and those authorized by NOR
 license to use the content for any educational, historical, or non-commercial purpose through
 any media now known or later developed.
- You will not be compensated for your submission.
- You will not submit content that is off-topic, partisan-political, contains personal attacks or
 expletives, or is otherwise abusive, threatening, unlawful, harassing, discriminatory, libelous,
 obscene, false, pornographic, or that infringes on the rights of any third party.
- You will only submit content that you own or for which you have received permission from the person or entity that owns the content and intellectual property rights.
- You understand that NOR monitors submitted content and reserves the right to refuse to use, publish, or otherwise disseminate any submission.
- By submitting content, you waive any privacy expectations you may have regarding the submitted content. NOR may make the content you submit available to the general public online, at is premises, in a traveling exhibition, or in current and future projects created by NOR or partners authorized by NOR. NOR may submit the content you have provided to publicly available collection development and archive initiatives, including but not limited to, those at the Local History Collection of the Kern County Library, the legacy archives at the NOR Chamber, and other community history initiatives. The content you submit also may be shared with third parties in response to law enforcement, in response to public requests for information, and as NOR determines is required by applicable law or regulation. Do not submit any content or personally identifiable information that you do not want made public as NOR cannot guarantee your privacy.
- If your content is selected by NOR for posting, website visitors may share your content via social
 media websites such as Facebook, YouTube, or Twitter. You acknowledge that these sites
 operate independently of NOR and have their own privacy policies over which NOR has no

- control. In addition, comments with which you disagree may become associated with the content you submit.
- Any content you are submitting does not include photographs, full names, or any other personally identifiable information of children currently under the age of 18.
- You agree to defend, indemnify, and hold NOR and its sponsors and partners harmless against
 any claims asserted by any third parties that allege your submission violates their rights, or from
 any breach by you of these terms and conditions. You shall be responsible for any costs incurred
 by NOR, including reasonable attorneys' fees and costs, for defense or settlement of third-party
 claims.
